Annual Meeting Saturday, October 19, 2 p.m. at the Stanislaus County Main Library

Surveys and studies show that over 85% of the public thinks advance planning for end of life is important, yet fewer than 25% have done so.

While creating a plan for the conclusion of a good life may sound a bit morbid, its creation will save your loved ones incalculable time, money and suffering.

This year's Annual Meeting of The FCA of Stanislaus Merced, is scheduled for **Saturday, October 19**, 2 p.m., at the Stanislaus County Main Library, 1500 I Street, Modesto. The program will explore the importance of advance planning to remove the burden and uncertainty from your family and loved ones and makes clear your values and beliefs.

Local Attorney and FCA Board Member Julie Richardson will explore the options to consider in end of life planning and preparation. Julie, a graduate of UC Berkeley Law School with 17 years of experience, knows how confusing it can be



to contemplate making end of life plans and invites you to bring your questions. A brief business meeting will follow the program. The public is welcome and light refreshments will be served.

- When Jason Rosenthal's wife knew she was dying, she published a Modern Love essay, entitled "You May Want to Marry My Husband". In doing so, she gave her blessing to his remarriage. He received numerous responses from women who offered to take his wife's spot.

- California now has five ways to deal with human remains: whole body earth burial, cremation, whole body burial at sea, whole body donation and now (legal and soon to be available alkaline hydrolysis ("water cremation"). Washington State has gotten one step closer to adding yet another option: composting or "natural organic reduction." The process turns a body into compostable material in a few months, yielding a cubic yard of product, enough to fill two large wheelbarrows.
